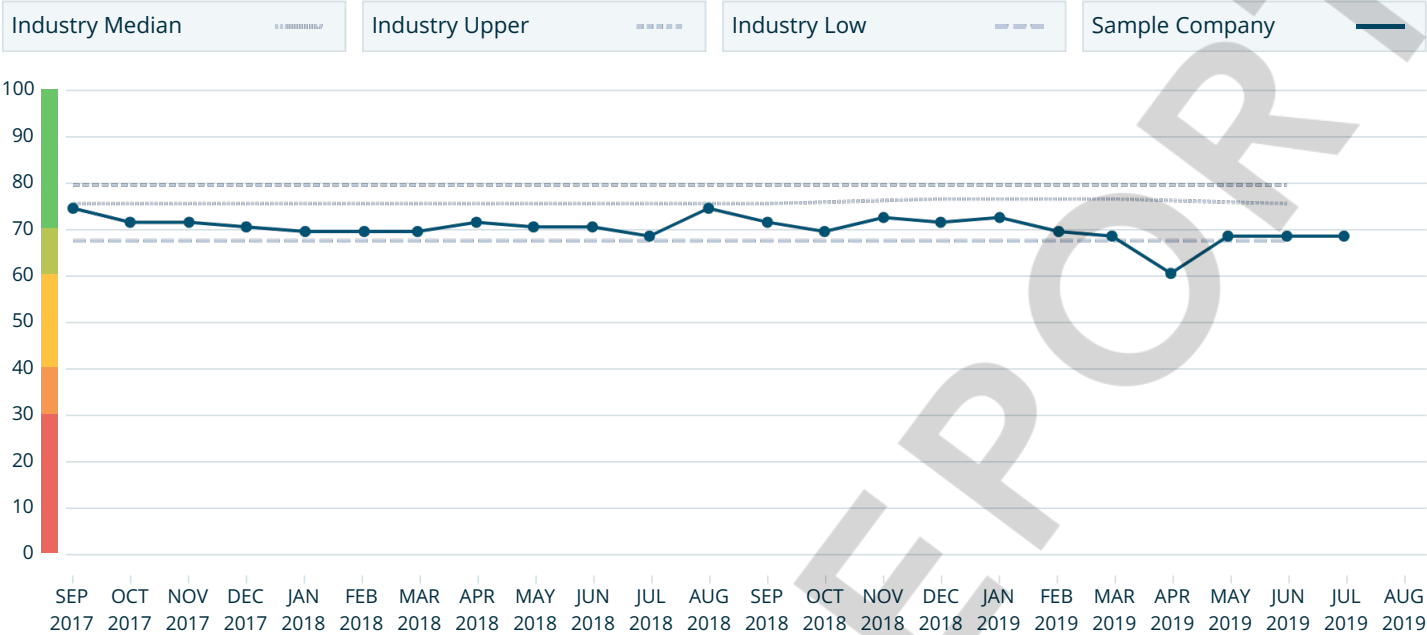

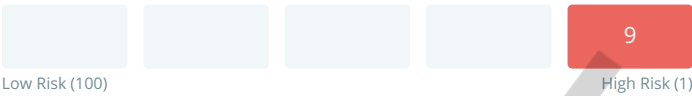

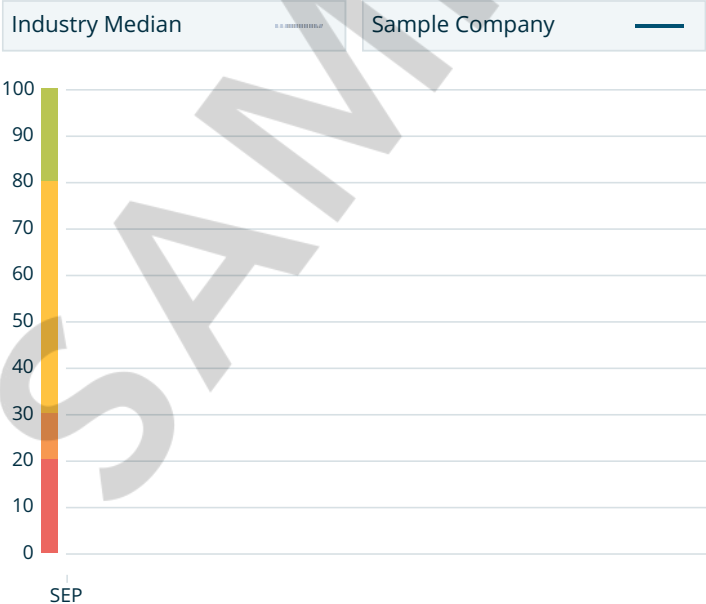

On January 9, 2017, the company acquired a 100% equity interest in Avention, Inc. (Avention). The acquisition was valued at \$150 million, net of cash acquired.

In 2016, the company completed the sales of its operations in Benelux and Latin America, converting these businesses to the company's Worldwide Network model.
